## 3. Police Department Report

Sergeant Dale Drummond reviewed the Police Department report for the month of September as well as the Police Department's assistance of the filming of a Netflix production in the city and preparations for Halloween. There was a discussion regarding AB 2147 which removes jaywalking from criminal status and will go into effect on January 1, 2023.

# 4. Traffic Engineering Quarterly Report

Senior Transportation Engineer Kevin Riley reported on relevant traffic/engineering projects from July to September 2022 including the Crosswalk Upgrade Project, the Citywide Signal Upgrade Project and speed hump installations. There was a discussion regarding requests for speed humps.

# 5. Monthly Educational Speaker Series – Evaluation of the "Idaho Stop" Laws in Other States

Transportation Planner Jessie Holzer Carpenter introduced Dr. David Hurwitz, Professor of Transportation Engineering at Oregon State University, who reviewed a study on the historical and safety impact of bicyclists and motorcyclists treating stop signs as yield signs at intersections. There was a discussion regarding the results of the study.

# 6. Beverly Hills Transit Feasibility Study

Transportation Planner Martha Eros presented a transit service plan to improve connectivity in the city. Peter Cassellini from Kittleson & Associates was introduced to review final recommendations and responses to the public transit survey. There was a discussion regarding the survey results and the suggested recommended future route. The Commissioners supported the staff recommendation to develop a pilot project consisting of fixed route circulator and microtransit. Route details will be prepared in the coming weeks and additional public outreach will be conducted before bringing back for Traffic and Parking Commission review in December.
